Sarah qualified as a Speech and Language Therapist in 1999 and since that time has worked in acute, rehabilitation and community settings with adults who have acquired a brain injury.

Between 2002 and 2005 Sarah worked in the Community Brain Injury Team (CBIT) as Senior Specialist SALT. CBIT are an NHS inter-disciplinary team providing assessment and intervention, in groups and 1:1. Concurrently, Sarah worked at the Wales Regional Neuropsychiatry Service, again as Senior Specialist SALT, where she remains to this day on a part time basis, alongside her independent SLT and Case Management practice.

In 2021, Sarah was seconded to the COVID Rehabilitation service and was integral to the rapid set up of an MDT service to meet the clinical needs of Long COVID, a developing condition.

Sarah is a calm, compassionate professional who is unfazed by challenging behaviours and chaotic, fast-moving situations. She takes a pragmatic approach and is an excellent communicator, well used to quickly developing and maintaining positive relationships with clients and their families. She is expert in the use of communication aides such as Talking Mats in goal setting and decision making, used frequently to support Mental Capacity Assessments and Best Interest decisions. One of her areas of special interest is the development of accessible information for patients/clients and digital project management.

Sarah is used to working to deadlines and is a highly skilled assessor and report writer. Managing the conflicting priorities of a caseload is second nature to her, as she is organised and focused. Sarah is well connected to a network of specialist therapists, medics, and services across all sectors, and is an effective interdisciplinary team coordinator. She has a great deal of experience in developing and implementing person-centred, highly individualised community rehabilitation programmes and works flexibly and creatively to ensure the client reaches their maximum potential.
